

Invoicing, cancellation fee and terms of payment

The registration fee and space rental will be invoiced

- as a single payment after registration.
- If the exhibitor wishes to be invoiced in two instalments, this should be stated in connection with the registration.
- In this case, the invoice for the first instalment will include the registration fee and 40 % of the space rental
- The final 60 % of the space rental will be invoiced after 24 March 2025.

Set stands and the small stands in the R&D area will be invoiced

- · in one instalment upon registration.
- If the exhibitor wishes to be invoiced in two instalments, this should be stated in connection with the registration.
- In this case, the first instalment invoice for the set stands will include the registration fee, service fee and 40 % of the space rental and stand structures. The final 60 % of the space rental and stand structures will be invoiced after 24 March 2025. For small stands, the first instalment of 600 € + VAT will be invoiced upon registration and the second instalment of 890 € + VAT after 24 March 2025.

Participation in the event requires that the registration fee and entire space rental have been paid in full before the start of the exhibition.

Cancellation fee

- If the exhibitor cancels the registration, the registration fee will not be refunded.
- If the registration is cancelled after 17 April 2025, the registration fee and an additional cancellation fee of 40 % of the space rental will be charged.

Terms of payment

- Payment is due within 14 days of the date on the invoice, or after 17 April 2025 within 7 days of the date on the invoice.
- Penal interest is charged in accordance with the Interest Act
- Extended terms of payment must be agreed on separately in connection with registration as an exhibitor.
- The Organiser charges a change fee of 20 € + VAT / invoice in cases where changes are made to the payment terms at the exhibitor's request or the space reservation is changed.
