

## YT27 -EXHIBITION – TERMS AND CONDITIONS OF EXHIBITION PARTICIPATION

**Admission:** Admission is free for visitors but requires registration in advance or at the main entrance of the exhibition. Advance registration can be made at [www.yhdyskuntatekniikka.fi](http://www.yhdyskuntatekniikka.fi).

**Evening gala for customers and invited guests:** The evening gala for customers and invited guests will take place in the exhibition area on Wednesday, 12 May 2027 from 5 p.m. to 7 p.m.

### 2. EXHIBITORS AND PRODUCTS

Exhibitors may be companies and their authorised representatives, private entrepreneurs, or representatives of public administration, corporations and registered associations. Exhibitors may not sublet or reassign their stands or a portion thereof without the written permission of the Organiser.

Exhibitors are responsible for ensuring that any product or service displayed at the exhibition does not pose a health risk to those in TESC during the event, that any required official permits necessary to display their products or services have been acquired and are valid, and that the displayed products or services do not violate any laws or third-party rights. The Organiser is entitled to remove any exhibits and services that may endanger or disturb others who are present at the event. All spaces and yard areas of Paviljonki are licensed and the exclusive right to serve drinks and food products is held by Restel Food & Events. No food or beverage products may be brought to the event.

The exhibition stand may only display the approved trade name of the exhibitor and the names of its principals and representatives. The exhibition stand can only display a name other than that of the exhibitor, its principals or representatives upon the approval of the Organiser. In such cases, the individual would be considered a co-exhibitor for whom a separate registration fee will be charged.

Exhibitors may distribute brochures or other marketing material for products and services that have been approved for the exhibition only at the exhibition stand, unless otherwise agreed upon with the Organiser. Retail sale at the stands is permitted.

### 3. REGISTRATION FEE, SPACE RENTALS AND INVOICING

**Exhibitor registration fee:** €300 + VAT / exhibitor from 1 January 2026. From 1 October 2026 onward, the registration fee will be €500 + VAT / exhibitor. The registration fee will be invoiced from the primary exhibitor as well as from each co-exhibitor.

**Space rentals:**

**Indoors:** € 119/m<sup>2</sup> + VAT. There is a 10% surcharge for corner stands with an area of 70 m<sup>2</sup> and smaller. The minimum area of an indoor stand is 6 m<sup>2</sup>, with the exception of specially-priced stands.

**Outdoors:** €55/m<sup>2</sup> + VAT. The minimum area of an outdoor stand is 20 m<sup>2</sup>. Indoor exhibitors can also rent a cold outdoor space for a fee of €30/m<sup>2</sup> + VAT. The minimum size of this type of space is 4 m<sup>2</sup>.

The rate of value added tax applicable at the time of invoicing will be added to the prices.

Upon payment of the registration fee, all exhibitors will receive exhibitor information sheets, access to the Extranet service and visibility on the Yhdyskuntatekniikka website and YT25 mobile application.

The space rental includes the stand space (including location measurement, marking and the numbering of facing boards), general security services, cleaning and general illumination of common hall areas, assembly, disassembly and exhibitor passes, as well as invitations to the exhibition. The space rental does not include, for example, any stand structures, electricity, furniture or stand cleaning. Electricity, stand cleaning and suspension points must be ordered in advance through the extranet service of Jyväskylän Fair Ltd. The suspension plan must be approved by Jyväskylän Fair Ltd. External parties are not permitted to hang anything or to provide their own electrical, water or compressed air connections. Construction, furnishing and logistics services are also available. If requested, Jyväskylän Fair Ltd will design a stand for exhibitors and price it accordingly. Additional services will be invoiced according to actual costs after the event.

**Invoicing of registration fees and space rentals:** The registration fee and space rental will be invoiced as a single payment after registration. If the exhibitor wishes to be invoiced in two instalments, this should be stated in connection with the registration. In this case, the invoice for the first instalment will include the registration fee and 50 % of the space rental. The final 50 % of the space rental will be invoiced after 15 February 2027. Any reservations made on the same day must be paid together as one instalment. Participation in the event requires that the registration fee and entire space rental have been paid in full before the start of the exhibition. The invoicing surcharge of €12 will only be charged for the first invoice.

**Invoicing of specially priced stands:** Ready-made stands and the small stands in the R&D area will be invoiced in one instalment upon registration. If the exhibitor wishes to be invoiced in two instalments, this should be stated in connection with the registration. In this case, the first instalment invoice will include the registration fee, recycling fee and 50 % of the space rental and stand structures. The final 50 % of the space rental and stand structures will be invoiced after 15 February 2027.

**Cancellation fee:** If the exhibitor cancels the registration, the registration fee will not be refunded. If the registration is cancelled after 1 April 2027, the registration fee and an additional cancellation fee of 50 % of the space rental will be charged.

**Terms of payment:** Payment is due within 14 days of the date on the invoice, or after 1 April 2027 within 7 days of the date on the invoice. Penal interest is charged in accordance with the Interest Act. Extended terms of payment must be agreed on separately in connection with registration as an exhibitor. The Organiser charges a change fee of €50 + VAT/invoice in cases where changes are made to the payment terms at the exhibitor's request or the space reservation is changed.

#### 4. REGISTRATION

A binding registration can be made using the registration form on the Organiser's website at [www.yhdyskuntateknikka.fi](http://www.yhdyskuntateknikka.fi). Upon receiving the registration, the Organiser will acknowledge it by sending a confirmation and a map showing the location of the stand to the exhibitor. The Organiser has the right to reject a registration. Registration will close 1 April 2027.

The Organiser's written confirmation is binding for both parties, as it regards the registration fee, exhibition stand and space rental. If neither party expresses any complaints, the booking confirmation becomes binding for both parties 14 days from the date of the booking confirmation. All complaints must be made in writing. If the registration is made on or after 1 April 2027, the booking is considered to be binding from the date of the confirmation.

#### 5. EXHIBITION STAND

Exhibition stands are assigned by the Organiser, primarily in the order of registration, while taking into account the appropriate use of the space available, the wishes of the exhibitors and the stand size of the exhibitor. The Organiser is entitled to limit the size of the exhibition stand. Enclosed with the order confirmation, the Organiser will send the exhibitor a map showing the location and size of the assigned stand. Maps of the exhibition area are available on the Organiser's website at [www.yhdyskuntateknikka.fi](http://www.yhdyskuntateknikka.fi).

The organiser has the right to change the location of stands if required for the overall benefit of the exhibition.

Exhibitors may not begin to empty or dismantle their stands prior to the start of the disassembly time.

## 7. SECURITY, DAMAGES AND INSURANCE

The Organiser is responsible for ensuring general order and security within the exhibition area. The exhibitor is liable for any personal injuries, material damage and financial losses to exhibition guests, other exhibitors, the Organiser and/or fair area caused by the structures, devices, exhibit materials or activities and subcontractors related to their stand.

The receipt and acknowledgement of exhibit materials in the exhibition area are always the responsibility of the exhibitor.

Each exhibitor shall independently undertake to acquire the necessary and comprehensive product, operational, theft and other liability insurances.

## 8. DEMONSTRATIONS AND PROGRAMME AT THE EXHIBITION STANDS

Any programme arranged at stands cannot obstruct walkways or disturb other exhibitors or exhibition guests, for example, because of excessively loud sound levels. The Organiser is entitled to interrupt/refuse the realisation of the programme at the stand if it is considered to be disturbing.

All stand activities must take place within the exhibitor's own reserved stand area.

Exhibitors are responsible for the copyright royalties related to any live music or recordings played at their stands. Further information: [www.teosto.fi](http://www.teosto.fi).

## 9. POSTPONEMENT OR CANCELLATION OF EXHIBITION

The organiser assumes no liability for any delays or damages caused by the exhibition being cancelled or adjourned to a later date due to a force majeure or order of a public authority (for, e.g. a pandemic).

The organiser reserves the right to postpone an event due for the aforementioned reasons to another date for which the exhibitors' participation will also be postponed.

If the exhibition must be cancelled, the organiser will keep the registration fee and return any paid rental fees for stands.

## 10. OTHER RULES AND REGULATIONS

In addition to these Terms and Conditions of Exhibition Participation, exhibitors shall comply with the General Terms of Participation, General Instructions for Exhibitors and safety guidelines of Jyväskylä Fair Ltd.

Any possible dispute situations arising from the terms and conditions of participation shall be settled in the following order of validity:

1. YT27 -exhibition – Terms and conditions of exhibition participation
2. General Terms of Participation of Jyväskylä Fair Ltd
3. General Instructions for Exhibitors of Jyväskylä Fair Ltd.

All exhibitors shall comply with the valid Finnish legislation.

Exceptions to these Terms and Conditions of Exhibition Participation and the general instructions are allowed only by permission of the Organiser. The Finnish-language Terms and Conditions of Participation and General Instructions shall serve as the primary documents in case of any interpretation disputes.

Any disputes that arise between the organiser and exhibitors shall endeavour, first, to be resolved through negotiations. If an agreement cannot be reached, the matter will be settled by a mediator or the District Court of Central Finland.
