Invoicing, cancellation fee and terms of payment

The registration fee and space rental will be invoiced

- as a single payment after registration.
- If the exhibitor wishes to be invoiced in two instalments, this should be stated in connection with the registration.
 - In this case, the invoice for the first instalment will include the registration fee and 50 % of the space rental.
 - The final 50 % of the space rental will be invoiced after 15 February 2027.
 - The invoicing surcharge of €12 will only be charged for the first invoice.

Ready-made stands and the small stands in the R&D area will be invoiced

- in one instalment upon registration.
- If the exhibitor wishes to be invoiced in two instalments, this should be stated in connection with the registration.
 - In this case, the first instalment invoice will include the registration fee, recycling fee and 50 % of the space rental and stand structures.
 - The final 50 % of the space rental and stand structures will be invoiced after 15 February 2027.
 - The invoicing surcharge of €12 will only be charged for the first invoice.

Participation in the event requires that the registration fee and entire space rental have been paid in full before the start of the exhibition.

Cancellation fee

- If the exhibitor cancels the registration, the registration fee will not be refunded.
- If the registration is cancelled after 1 April 2027, the registration fee and an additional cancellation fee of 50 % of the space rental will be charged.

Stand structures and electricity in cancellation situations

- If the cancellation is made after 27 April 2027, a cancellation fee will be charged along with a 100% of the costs for any stand structures and electrical connections ordered from Paviljonki.
- If the exhibitor wishes to modify the stand structures within a package deal after the stand has been confirmed, the price reduction resulting from the changes will not be refunded.

Terms of payment

- Payment is due within 14 days of the date on the invoice, or after 1 April 2027 within 7 days of the date on the invoice.
- Extended terms of payment must be agreed on separately in connection with registration as an exhibitor.
- Penal interest is charged in accordance with the Interest Act.
- The Organiser charges a change fee of €50 + VAT /invoice in cases where changes are made to the payment terms at the exhibitor's request or the space reservation is changed.
